We recommend installing each lighting strip using Adhesion Promoter, which allows for a much stronger bond between the adhesive tape of the light strips and the cleaned mounting surface of your Softail.

PLEASE READ THE FOLLOWING INSTRUCTIONS THOROUGHLY BEFORE INSTALLING AND OPERATING THIS LED HARLEY DAVIDSON SOFTAIL 315-LED LIGHTING KIT.

- Upon receiving your new Harley Davidson Softail Lighting Kit, we ask that you first test the kit to ensure it is functioning correctly. Plug the male connections from the strips and control box into the female connections of the harnesses. Connect the red power wire to the positive terminal of the battery and the black ground wire to the negative terminal of the battery. Once the wires are temporarily secure, power the kit to ensure full functionality before installing it. If everything appears to be working correctly, turn the kit off and disconnect the power and ground wires from the battery to prepare for installation.
- Prepare the bike for installation by removing the seat, and any panels that may be in your way. Removing the fuel tank will make running wires a lot easier.


Note: The strips can be mounted in any area that isn't hot or near moving parts. However, we recommend installing the light strips in the locations on page 3.


- 3. Recommended mounting locations:
 - (2) 27-LED Strips For Fuel Tank
 - (2) 27-LED Strips For Front Frame
 - (1) 18-LED Strip For Belt Guard
 - (4) 18-LED Strips For Front Fender
 - (1) 18-LED Strip For Air Cleaner
 - (6) 9-LED Strips For Upper & Lower Swingarm
 - (2) 9-LED Strips Front Of Rear Frame
 - (1) 9-LED Strips For Horn
 - (1) 9-LED Strip For Transmission Cover
 - (1) 9-LED Strip For Brake Caliper
- 4. The surface area must be free of all oils, moisture, dirt, and wax so that the supplied adhesive tape can bond and adhere to the installation surface correctly. Be sure to clean all of the mounting areas with alcohol prep pads and apply adhesion promoter to the cleaned areas.
- Attach the strips by pressing firmly onto the desired mounting locations.

- 6. Mount (4) 18-LED strips on the front fender brackets, and mount those brackets to each side of the fender in the locations shown on the next page.
- Mount (2) 27-LED strips on the front of the frame facing the engine.
- 8. Mount a 9-LED strip on the horn.
- 9. Mount a 18-LED strip on the air cleaner.
- 10. Mount (1) 9-LED strip on the right side of the transmission cover.
- 11. Mount (1) 9-LED strip on the upper right tube of the swingarm firing down.
- 12. Mount (2) 9-LED strips on each side of the front of the rear frame.
- 13. Mount (1) 9-LED strip on the upper right tube of the swingarm firing in toward the wheel.
- 14. Mount (1) 9-LED strip on the lower right tube of the swingarm firing in toward the wheel.
- 15. Mount (1) 9-LED strip on the right side of the brake caliper.
- 16. Mount (1) 9-LED strip on the upper left tube of the swingarm firing down.
- 17. Mount (1) 9-LED strip on the upper left tube of the swingarm firing in toward the wheel.
- 18. Mount (1) 9-LED strip on the lower left tube of the swingarm firing in toward the wheel.
- 19. Mount (1) 18-LED strip on the belt guard.
- 20. Mount (2) 27-LED strips on the bottom of the fuel tank.
- 21. See page 4 for extension and splitter connection locations.



Note: The strips can be mounted in any area that isn't hot or near moving parts.







Wire Extensions & Splitter Connection Locations:

Front Fender - (3) 1 To 2 Connectors and (1) 36" Extension

Horn and Air Cleaner - (1) 18" Extension Each

36" Extension from the Front Fender, Horn and Air Cleaner 18" Extensions, and the Front Frame LED strips all connect to a 5 to 1 connector. Hide the 5 to 1 in the frame pocket near where the fuel tank mounts.

Lower Tube On Left Side Of Swingarm - (1) 36" Extension

Belt Guard and Top Tube of Swingarm - (1) 1 To 2 Connector

Rear Frame and Top Tube of Swingarm Inner - (1) 1 To 2 Connector

Bottom Tube On Right Side Of Swingarm and Brake Caliper - (1) 1 To 2 Connector and (1) 36" Extension and (1) 5 to 1 connector.

Transmission Cover - (1) 18" Extension

Top Tube Of Swingarm Inner and Down, Rear Frame, and Transmission Cover Extension all connect to a 5 to 1 connector.

Wireless Remote Functions

This kit provides multiple lighting patterns and seven different colors, which are easily operated using the included wireless remote. The remote includes four buttons, "Power, A, B, C".

Button A: Cycles through 7 solid colors and 8 different lighting patterns.

Button C: Press this button to slow down the different lighting patterns.

Button B: Press this button to speed up the different lighting patterns.

Power Button: Press this button to turn the lights on/off.

Troubleshooting:

If the kit or lights do not appear to operate, first check the installed in-line mini fuse. If the fuse is blown, check the wires on the entire kit to ensure they are not cut, pinched, or scorched. If there is no damage to any of the wires and to the control box, replace the fuse and test the kit again. If the in-line fuse is intact, clean both the positive and negative terminals of the battery. Corrosion to the battery terminals can cause a poor connection or simulate being disconnected.
