We recommend installing each lighting strip using Adhesion Promoter, which allows for a much stronger bond between the adhesive tape of the light strip and the cleaned mounting surface of your motorcycle.

PLEASE READ THE FOLLOWING INSTRUCTIONS THOROUGHLY BEFORE INSTALLING AND OPERATING THIS 252-LED HARLEY DAVIDSON TOURING LIGHTING KIT.

- Upon receiving your new Harley Davidson Touring Lighting Kit, we ask that you first test the kit to ensure it is functioning correctly. Plug the male connections from the strips and control box into the female connections of the harnesses. Connect the red power wire to the positive terminal of the battery and the black ground wire to the negative terminal of the battery. Once the wires are temporarily secure, power the kit to ensure full functionality before installing it. If everything appears to be working correctly, turn the kit off and disconnect the power and ground wires from the battery to prepare for installation.
- Prepare the bike for installation by removing the saddlebags, seat, fuel tank, and any panels that may be in your way.

Note: The strips can be mounted in any area that isn't hot or near moving parts. However, we recommend installing the light strips in the locations on page 4.

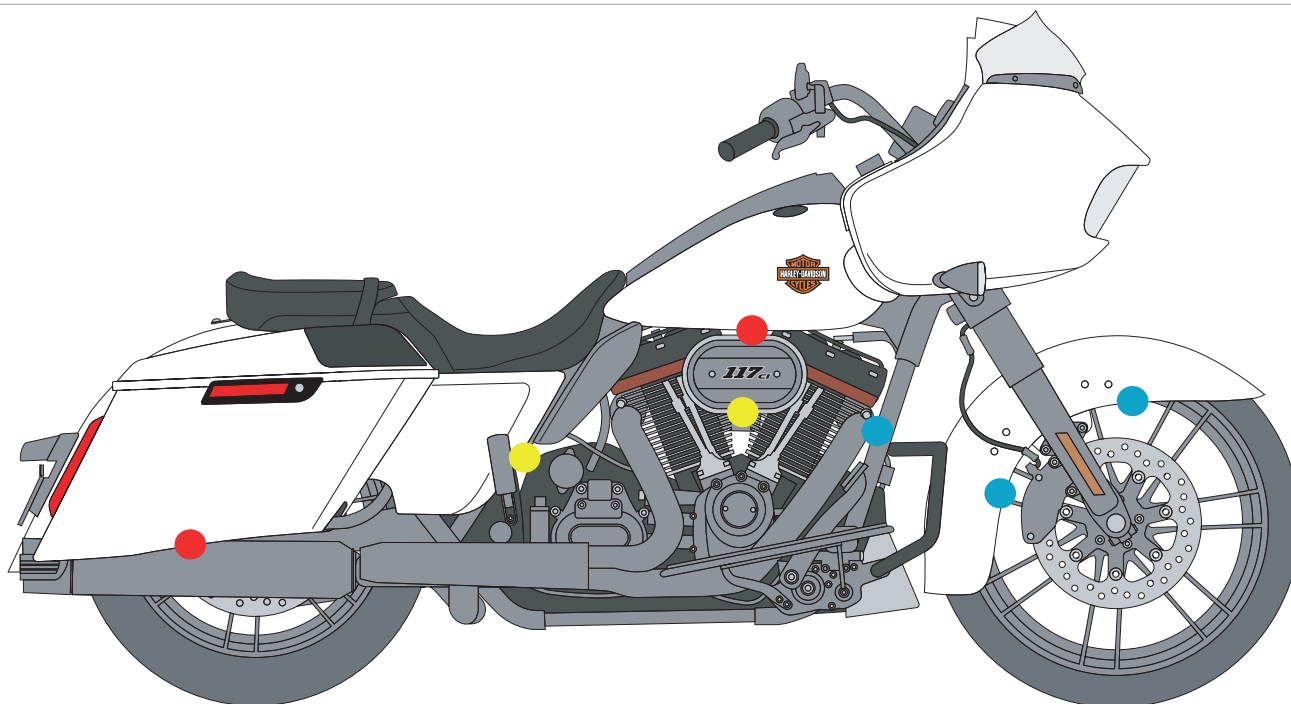
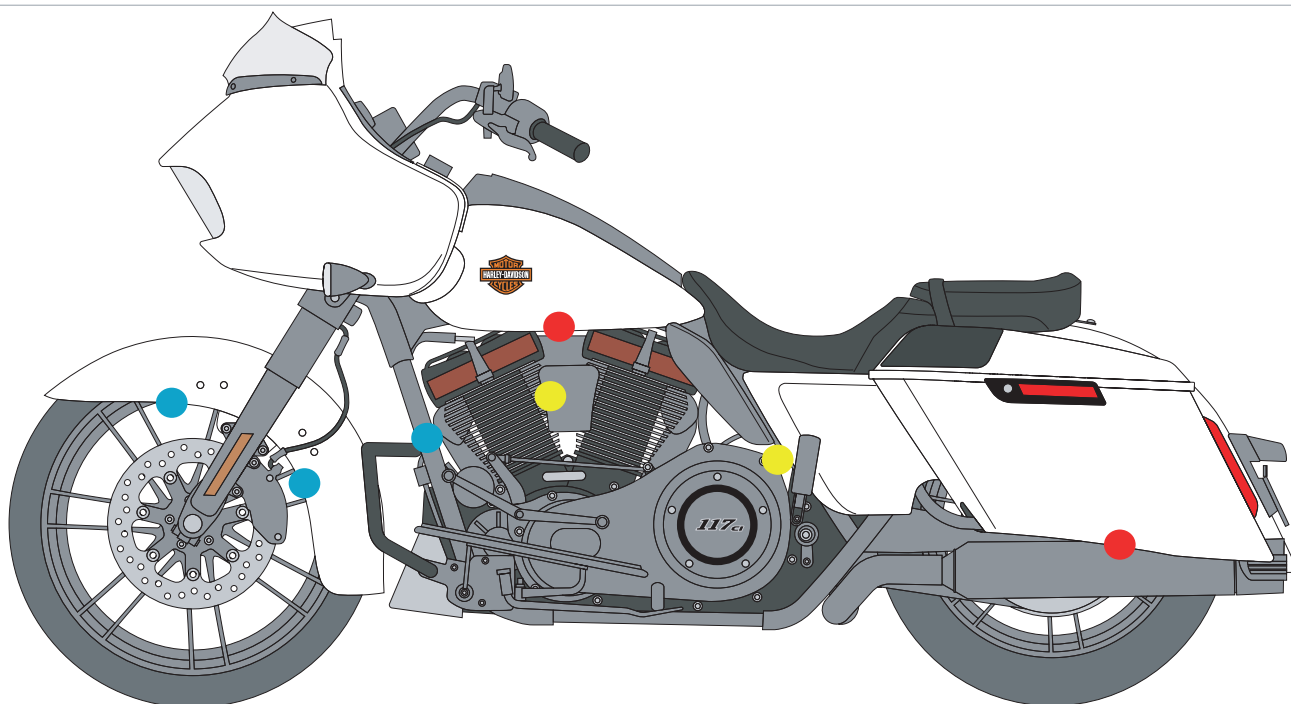
3. Recommended mounting locations:

- (1) 9-LED Strip On Bottom Of Horn
- (1) 9-LED Strip On Bottom Of Air Cleaner
- (1) 9-LED Strip On Left Rear Frame
- (1) 9-LED Strip On Right Rear Frame
- (1) 18-LED Strip On Front Left Frame
- (1) 18-LED Strip On Front Right Frame
- (4) 18-LED Strips On Front Fender
- (2) 27-LED Strips On Bottom Of Fuel Tank
- (2) 27-LED Strips On Bottom Of Saddle Bag Rails

- The surface area must be free of all oils, moisture, dirt, and wax so that the supplied adhesive tape can bond and adhere to the installation surface correctly. Be sure to clean all of the mounting areas with alcohol prep pads and apply adhesion promoter to the cleaned areas.

- Mount (4) 18-LED strips on the front fender brackets, and mount those brackets to each side of the fender in the locations shown on the next page.
- Mount (2) 18-LED strips on the left and right front frame downtubes facing the engine.
- Mount (1) 9-LED strip on the horn, and (1) 9-LED strip on the air cleaner.
- Mount (2) 9-LED strips on each side of the rear frame.
- Mount (2) 27-LED strips on the bottom of each saddle bag rail.
- Mount (2) 27-LED strips on the bottom of each side of the fuel tank.

Note: The strips can be mounted in any area that isn't hot or near moving parts.



7 Color Remote Instructions

Wireless Remote Functions

This kit provides multiple lighting patterns and seven different colors, which are easily operated using the included wireless remote. The remote includes four buttons, "Power, A, B, C".

Button A: Cycles through 7 solid colors and 8 different lighting patterns.

Button C: Press this button to slow down the different lighting patterns.

Button B: Press this button to speed up the different lighting patterns.

Power Button: Press this button to turn the lights on/off.

Troubleshooting:

If the kit or lights do not appear to operate, first check the installed in-line mini fuse. If the fuse is blown, check the wires on the entire kit to ensure they are not cut, pinched, or scorched. If there is no damage to any of the wires and to the control box, replace the fuse and test the kit again. If the in-line fuse is intact, clean both the positive and negative terminals of the battery. Corrosion to the battery terminals can cause a poor connection or simulate being disconnected.

18 Color Remote Instructions

Key Features:

18 Solid Color Include:

- Red, Blue, Green, White, Yellow, Pink, Ice Blue, Purple and many more
- 1st-7th Color Cycle Flashing and Fading Modes.
- 1st-18th Color Flashing and Fading Mode.
- Brake override function

Brake override function allows the controller to interrupt color modes and activate only red while braking.

Remote Control Function:

Button A:

This is the main function key, press it once, it shows a color pattern (1st-18th), in static mode, Long press the A key to the current LED stepless dimming.

Button B:

The gradient or hopping mode (19th-20), long press B to achieve healthy color shift from slow to fast, in static mode (1st-18th), press B, lights from the current mode static to blink.

Button C:

In the gradient or hopping mode (19th-20th), press C to achieve healthy color change from fast to slow, in static mode (1st-18th), press C, lights from the current mode static to change slowly fades.

Button D:

Press D to control controller ON and OFF. At 2nd-18th color Press D for 3 seconds the system will be return 1st color (red).

Remote Distance: Max 30ft
